If I have any children born or adopted after execution of this Will, they shall receive equal shares in my estate as if named herein unless I have provided otherwise by a written codicil.

**ARTICLE VIII - SIMULTANEOUS DEATH**

If my spouse and I die under circumstances rendering it difficult to determine who died first, I direct that I be deemed to have survived my spouse for purposes of this Will.

**ARTICLE IX - NO CONTEST CLAUSE**

If any beneficiary under this Will contests this Will or any of its provisions, any share or interest in my estate given to that contesting beneficiary is hereby revoked and shall be disposed of as if that contesting beneficiary had predeceased me.

**ARTICLE X - GOVERNING LAW**

This Will shall be governed by and construed in accordance with the laws of the State of Alaska.
