1. Lease Grant and Acceptance

Landlord hereby leases to Tenant, and Tenant hereby accepts, the home office premises described above, subject to the terms and conditions contained in this Agreement.

2. Use of Premises

The Premises shall be used solely as a home office workspace and for no other purpose without prior written consent of Landlord. Tenant shall comply with all applicable laws, ordinances, and regulations.

3. Lease Term

The Lease shall commence on the Agreement Date and shall continue for the Lease Duration specified above, unless terminated earlier in accordance with this Agreement.

4. Rent

Tenant agrees to pay the Monthly Rent Amount in United States Dollars, due in advance on the Payment Due Date Each Month to the Landlord at the address specified or at such other place as Landlord shall designate in writing.

5. Security Deposit

Tenant shall pay a Security Deposit as stated above to secure Tenant's obligations under this Agreement. The Security Deposit shall be held by Landlord in a separate account and may be used to cover damages, unpaid rent, or other defaults by Tenant.

6. Maintenance and Repairs

Tenant shall keep the Premises clean and in good condition. Tenant shall promptly notify Landlord of any damage or needed repairs. Landlord shall be responsible for repairs not caused by Tenant's negligence or misuse.

7. Utilities and Services

Unless otherwise agreed in writing, Tenant shall be responsible for all utilities and services required in connection with the Premises, including but not limited to electricity, internet, and telephone.

8. Alterations and Improvements

Tenant shall not make any structural alterations or improvements to the Premises without prior written consent of Landlord. Any approved improvements shall become property of Landlord unless otherwise agreed.

9. Access

Landlord or Landlord's agents may enter the Premises upon reasonable notice to Tenant for inspection, repairs, or to show the Premises to prospective tenants or purchasers, except in cases of emergency.

10. Insurance and Liability

Tenant is responsible for obtaining any insurance covering Tenant's personal property and liability. Landlord shall not be liable for any damage or injury to Tenant or Tenant's property except as caused by Landlord's gross negligence or willful misconduct.

11. Indemnification

Tenant agrees to indemnify and hold Landlord harmless from and against any and all claims, damages, liabilities, and expenses arising from Tenant's use of the Premises, except to the extent caused by Landlord's gross negligence or willful misconduct.

12. Default and Remedies

If Tenant fails to pay rent or breaches any other terms of this Agreement, Landlord may provide written notice to Tenant. If Tenant does not cure the breach within the applicable notice period, Landlord may terminate this Agreement and pursue all legal remedies.

13. Termination

This Agreement may be terminated upon expiration of the Lease Term or earlier by mutual written consent of the parties or as otherwise provided herein.

14. Surrender of Premises

Upon termination or expiration of this Agreement, Tenant shall surrender the Premises in as good condition as received, reasonable wear and tear excepted.

15. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable state laws governing residential or commercial leases, without regard to conflict of law principles.

16. Entire Agreement

This Agreement contains the entire agreement between the parties relating to the subject matter and supersedes all prior understandings, agreements, or representations.

17. Amendments

Any amendment or modification to this Agreement must be in writing and signed by both parties.

18. Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

19. Notices

All notices required or permitted hereunder shall be in writing and delivered personally or sent by certified mail, return receipt requested, or by nationally recognized overnight courier to the addresses provided above or to such other address as either party may designate in writing.

20. Counterparts and Electronic Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, and may be executed by electronic signature, which shall be deemed to have the same legal effect as an original signature.
