

LAST WILL AND TESTAMENT

ARTICLE I: IDENTIFICATION

ARTICLE IV: GUARDIANSHIP

If at my death any of my children are under the age of eighteen (18) years, I appoint _____

ARTICLE V: BOND

No bond or other security shall be required of any Personal Representative or guardian appointed by this Will.

ARTICLE VI: TAXES AND DEBTS

I direct that all my just debts, funeral expenses and expenses of administering my estate be first paid from my estate, and that all estate, inheritance, and succession taxes (including any interest and penalties) payable by reason of my

death be paid from my residuary estate, without apportionment.

ARTICLE VII: OMISSION

Except as otherwise provided in this Will, I have intentionally omitted to provide for any heirs or persons not named herein, whether known or unknown to me.

ARTICLE VIII: SIMULTANEOUS DEATH

If any beneficiary and I die under circumstances where it is difficult to determine who died first, I direct that the beneficiary shall be deemed to have predeceased me.

ARTICLE IX: NO CONTEST CLAUSE

If any beneficiary under this Will contests this Will or any of its provisions, any share or interest in my estate given to such contestant shall be forfeited and shall become part of my residuary estate.

ARTICLE X: GOVERNING LAW

This Will shall be governed by and construed in accordance with the laws of the State of Mississippi.
