### Section 1 – Agreement to Adopt

Owner agrees to transfer ownership of the described pet to the Adopter. Adopter agrees to accept ownership and care for the pet under the terms specified herein.

### Section 2 – Pet Condition and AS-IS WHERE-IS

The pet is adopted AS-IS, WHERE-IS, with all known and unknown faults. Owner makes no warranties, express or implied, regarding the health or behavior of the pet, except as specifically stated in this Agreement.

### Section 3 – Health Records and Vaccinations

Owner shall provide Adopter with all available health records, vaccination history, and veterinary care documents. Adopter acknowledges receipt of these records and understands that continued care is the responsibility of the Adopter.

### Section 4 – Spay/Neuter Agreement

If the pet has not been spayed or neutered, the Adopter agrees to have this procedure performed by a licensed veterinarian within the time frame required by local laws and to provide proof of completion to the Owner upon request.

### Section 5 – Care and Welfare

Adopter agrees to provide proper food, water, shelter, medical care, and humane treatment to the pet at all times. Adopter shall not abandon, neglect, or abuse the pet, and shall comply with all applicable laws and regulations.

**Section 6 – Return Policy**

If for any reason the Adopter is unable or unwilling to keep the pet, the Adopter agrees to notify the Owner promptly and return the pet in good health and condition. The Owner reserves the right to refuse adoption transfer to any third party.

**Section 7 – Liability and Indemnification**

Adopter assumes all liability for the pet after the transfer of ownership. Owner shall not be responsible for any damages, injuries, or losses caused by the pet after adoption. Adopter agrees to indemnify and hold Owner harmless from any claims arising from pet ownership.

**Section 8 – Legal Compliance**

Both parties agree to comply with all federal, state, and local laws related to pet ownership, licensing, vaccinations, and care. This Agreement shall be governed by the laws of the State of \_\_\_\_\_ without regard to conflicts of law principles.

**Section 9 – Entire Agreement**
