Terms and Conditions:

1. Deposit Purpose

The Deposit shall secure the Buyer's intent to purchase the Puppy described above from the Seller under the terms herein.

2. Deposit Application

The Deposit will be applied toward the total purchase price at the time of final sale.

3. Non-Refundable Deposit

The Deposit is non-refundable except under the conditions stated herein. If Buyer fails to complete the purchase without valid reason, the Deposit shall be forfeited.

4. Refund Conditions

The Deposit shall be refunded in full if the Seller is unable to deliver the Puppy as described, or if the Puppy is found to have undisclosed health conditions prior to transfer.

5. Transfer of Ownership

Ownership and risk of loss will transfer upon full payment and delivery of the Puppy.

6. Health Guarantee

Seller guarantees that the Puppy is in good health at the time of transfer and will provide applicable health records, vaccinations, and veterinarian documentation.

7. Buyer's Responsibility

Buyer agrees to provide proper care, including veterinary examinations and vaccinations, following transfer.

8. No Warranty Beyond Deposit

Except for the health guarantee stated, no other warranties, expressed or implied, are made by the Seller.

9. Legal Compliance

This Agreement is governed by the laws of the United States of America and the applicable state laws. Any disputes shall be resolved under such jurisdiction.

10. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written.

11. Amendments

Any amendments or modifications must be made in writing and signed by both parties.

12. Severability

If any provision is found invalid or unenforceable, the remainder shall remain in full force and effect.

13. Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original.

14. Buyer's Acknowledgment

Buyer acknowledges having received all pertinent information regarding the Puppy and had the opportunity to ask questions.

15. Seller's Representations

Seller represents that the Puppy is free of liens, claims, or encumbrances and that Seller has full right to sell the Puppy.

16. Governing Law and Venue

Buyer and Seller agree that any legal proceedings arising from this Agreement shall be brought exclusively in the courts of the state governing this Agreement.

17. Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement.

18. Binding Effect

This Agreement shall be binding upon and inure to the benefit of the parties and their respective heirs, executors, administrators, and assigns.

19. No Oral Modifications

No oral modifications to this Agreement shall be binding unless in writing and signed by both parties.

20. Notices

All notices required or permitted hereunder shall be in writing and delivered personally, by certified mail, or by recognized overnight courier service to the addresses provided herein.
