3. Odometer Disclosure:

Seller certifies the odometer reading to be accurate to the best of Seller's knowledge and that it reflects the actual mileage of the vehicle unless otherwise stated.

4. Risk of Loss:

Risk of loss or damage passes to Buyer upon delivery of the vehicle.

5. Taxes and Fees:

Buyer is responsible for all registration, title transfer fees, taxes, and any other governmental fees associated with this purchase.

6. No Refunds:

All sales are final. No refunds or returns are allowed once the vehicle is delivered and payment is completed.

7. Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of Michigan. Any disputes arising hereunder shall be resolved exclusively in the state or federal courts located in Michigan.

8. Entire Agreement:

This document constitutes the entire agreement between the parties with respect to the sale of the vehicle and supersedes all prior agreements, understandings, and representations.

9. Severability:

If any provision of this Agreement is deemed invalid or unenforceable, the remainder shall remain in full force and effect.

10. Amendments:

Any amendments to this Agreement must be in writing and signed by both parties.

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together constitute one and the same instrument.
