1. Agreement to Purchase and Sell

Seller agrees to sell and Buyer agrees to purchase the described goods subject to the terms and conditions set forth in this Agreement.

2. Representations and Warranties

Seller represents that Seller is the legal and rightful owner of the goods and has full authority to sell the goods free of liens, claims, and encumbrances. Buyer acknowledges the opportunity to inspect the goods prior to purchase.

3. Condition of Goods; AS-IS

The goods are sold AS-IS, WHERE-IS, with all faults and without warranty except as expressly stated in this Agreement.

4. Payment

Buyer shall pay the Purchase Price as specified herein by the agreed methods and within agreed timeframes. Failure to pay punctually may result in default and remedies as outlined herein.

5. Delivery and Risk of Loss

Delivery of the goods shall be made at the location specified. Risk of loss shall pass to Buyer upon delivery of the goods.

6. Taxes, Fees, and Other Charges

Buyer shall be responsible for all applicable taxes, duties, fees, and charges arising from the purchase and ownership of the goods.

7. Default and Remedies

In the event either party breaches this Agreement, the non-breaching party may pursue all remedies available at law or equity, including specific performance, damages, or termination of this Agreement.

8. Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Parties consent to the exclusive jurisdiction and venue of the courts located in _____ County, _____.

9. Entire Agreement; Amendments

This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior agreements. Amendments must be in writing and signed by both parties.

10. Notices

All notices required or permitted under this Agreement shall be in writing and deemed properly delivered when sent by hand, certified mail, overnight courier, or electronic means to the addresses of the parties.

11. Severability

If any provision of this Agreement is held invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

12. Counterparts and Execution

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which constitute one and the same instrument. Electronic signatures shall be binding.
