

LAST WILL AND TESTAMENT

I,

, being of sound mind and legal age, declare this to be my Last Will and Testament.

ARTICLE I – DECLARATION

I hereby revoke all wills and codicils previously made by me. I declare that I am a resident of the State of Vermont. This Will reflects my personal desires concerning the disposition of my estate in the event of my death.

ARTICLE III – APPOINTMENT OF PERSONAL REPRESENTATIVE

as Personal Representative (Executor) of my estate, without bond, to serve without compensation and to act with full powers as provided by law.

ARTICLE IV – PAYMENT OF DEBTS AND EXPENSES

I direct my Personal Representative to pay all my just debts, funeral expenses, and expenses of administering my estate as soon after my death as practicable.

ARTICLE V – DISPOSITION OF PROPERTY

I give, devise, and bequeath my estate as follows:

ARTICLE VI – GUARDIANSHIP

If at my death any of my children are under the age of eighteen (18) years, I nominate and appoint:

ARTICLE VII – TAXES AND EXPENSES

All estate, inheritance, succession, and other death taxes and expenses payable by reason of my death shall be paid out of my residuary estate without apportionment.

ARTICLE VIII – OMISSION

If I fail to provide for any of my children or descendants who survive me, it is my intent that they shall receive nothing by this Will.

ARTICLE IX – CONSTRUCTION AND GOVERNING LAW

This Will shall be governed by and construed in accordance with the laws of the State of Vermont. If any provision of this Will is invalid or unenforceable, the remaining provisions shall remain in full force and effect.

ARTICLE X – NO CONTEST CLAUSE

If any beneficiary under this Will contests this Will or any of its provisions, any share or interest in my estate given to that person shall be forfeited and shall become part of the residuary estate.
